SPECIAL DISCOUNTS

The **Early Bird Discounts** offer \$100 off the price of registration when the \$500 camp deposit is made by October 31, 2011 or \$50 off when the \$500 camp deposit is made by February 28, 2012. After the early bird deadlines have passed, these offers are no longer valid.

The **Sibling Discount** is available to any camp family with more than one child attending Gesher. Second and third children receive a \$100 reduction in the tuition fee each, while the fourth child receives \$500 off.

The **Jewish Day School Discount** is available to any camper who is currently enrolled at the Joseph Kushner Hebrew Academy, Solomon Schechter Day School, the Hebrew Academy of Morris County, or any other full-time Jewish Day School. These students receive a \$100 discount.

The \$200 **Transportation Discount** is awarded to every camper who chooses not to receive transportation (both directions) or to whom transportation is not available.

The **Loyalty Discount** is a \$50 per year *per family* cumulative discount for every year that your family had been a participant at Gesher, starting with your second year. For example, if this is your family's fourth Gesher summer, we will automatically credit your account \$150.

The **Refer-a-Family Discount** awards \$50 to Gesher families for referring their friends who attend Gesher in 2012 for the first time. To earn this discount, the referred family must list your name on their application and they must attend Gesher for a minimum of four weeks. This is a per family, not per camper, discount. Former Gesher families do not qualify as new Gesher families. There is no limit to the number of referral awards that can be earned.

TERMS OF AGREEMENT (Please read carefully)

- **DEPOSIT OF \$500, 50% Non-Refundable after December 31, 2011** to be paid for each camper with application.
- In accepting enrollment, Gesher reserves a place for the child and contracts services for each child. If, for any reason, the enrollment must be cancelled, Gesher must be advised of this in writing with the following understanding: any cancellation between January 1 and May 15 will incur the loss of \$250; cancellations between May 15 and June 25 will incur a \$500 cancellation fee; cancellation after the first day of camp will incur the forfeiture of the first session's (four weeks) tuition.
- If the Camper's conduct or influence is harmful to the best interests of Gesher, the Camper may be dismissed at the sole discretion of the Director with no refund nor reduction of fee.
- I hereby authorize the officials of Gesher to render whatever treatment he/she may deem necessary in the event of an emergency.
- I hereby give permission for photographs and video to be taken of my child and used for promotional material.
- **All necessary forms, completed medical and application, must be returned to the Gesher Office prior to the beginning of camp, otherwise your child will not be permitted on the bus or into camp.** (There will be no exceptions).
- **Registration and/or balance received after May 15, will incur an additional fee of \$100 per camper.**

BALANCE IS DUE ON OR BEFORE MAY 15, 2012

In the event Gesher is forced to resort to legal means to collect any outstanding amount due, we agree that we are obligated to pay the Gesher's reasonable attorneys fees plus any cost of court incurred by Gesher in the collection or enforcement of the debt owed.
